National Membership fee will be paid online. The State fee for NDJHRD will be paid at the first rodeo of the season! Check for \$40.00 payable to NDJHRD must be brought to first rodeo of the season.

_____ National Rodeo Membership Application completed and printed from the online portal. Instructions on website. Both parents/guardians MUST sign the bottom of this form along with the contestant and upload to the online membership portal. If only one parent signature due to deceased, sole custody, or incarcerated parent this must be noted on the form. Attach this document to the online membership portal using the drop down menu item specified.

_____ National Minor's Release, Assumption of Risk and Indemnity Agreement completed and printed from the online program. The natural Father and Mother or the Legal Guardian along with the contestant MUST sign this form. If only one parent signature due to deceased, sole custody, or incarcerated parent this must be noted on the form. This form needs to be Notarized (be sure notary lists contestant and both parents as being present when notarized). Attach this document to the online membership portal using the drop down menu item specified.

***_____North Dakota Waiver of Liability (on website). Both parents/guardians and the contestant MUST sign the form in 2 places. If only one parent signature due to deceased, sole custody, or incarcerated parent this must be noted on the form. This form needs to be Notarized (be sure notary lists contestant and both parents as being present when notarized). This document to be scanned with other ND documents below. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

***_____Certificate of Eligibility Public/Private School-home school see below (on website). Signed and current date by school officials. Fall rodeos only: Schools may be closed for the summer --you can upload this form prior to the draw out deadline of the first fall rodeo. This document to be scanned with other ND documents below. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

Spring Certificates of Eligibility and current grade report must be uploaded 3 weeks prior to first rodeo!

***_____ Home School Verification Form-for home school students only (on website). New NHSRA rule; the form must be completed and submitted for verification of accredited program or grade level

competency. See form for further explanation. <mark>This document to be scanned with other ND documents</mark> below. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

***_____ Current Grade Transcripts—<u>For Fall rodeos</u> it must be the end of year report card. <u>Spring</u> <u>rodeos</u> it must be 3rd quarter report card or 2nd Semester Report Card. Home School students must attach record of completion of the grade level spring or report card/progress report for end of school year spring. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

***_____ Online Entry Authorization (on website) Contestant and both parents sign. This document to be scanned with other ND documents below. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

***_____Code of Conduct (on website). Contestant and both parents sign. This document to be scanned with other ND documents below. Attach this document along with other ND documents with *** as one PDF and upload to the online membership portal.

_____ A W-9 must be completed if jackpotting and uploaded to the online portal. No JP allowed until the W-9 has been signed and uploaded. This will now only be needed once for Junior High and once for High School. Everyone must submit a W-9 for the 2025-2026 Season!

_____ Write the open and close dates for all online entries on your calendar.

_____ \$40.00 State Membership Fee made payable to NDJHRD- brought to the first rodeo! Must be paid prior to start of the rodeo!

NORTH DAKOTA JUNIOR HIGH CODE OF CONDUCT ISION

Any contestant or member will be disqualified from the rodeo, NHSRA event or other function for any of the following offenses. If they are disqualified for any of these offenses, they will be disqualified from all events or other participation in the rodeo, NHSRA event or other function.

- (1) Having any association with alcoholic beverages, narcotic, tobacco products or other non-medicinal drugs while in attendance at any approved High School or Junior High Rodeo or sanctioned activity, whether at a motel or on rodeo grounds or going to or from the rodeo or at any NHSRA function. The member will be suspended from further rodeo activity for 6 weeks. If they are disqualified for any of these offenses, they will be disqualified from all events or other participation in the rodeo, NHSRA event, or other function.
- (2) Rowdyism, quarreling or fighting in the actual domain of the arena at any time, or any place during the duration of the Rodeo.
- (3) Conduct or speech of any kind detrimental to the best interests of the NHSRA, NDHSRA, NDJHRD, or the sport of rodeo while in attendance, or coming to and going home from the rodeo.
- (4) Motel or property damage by contestants or their associates; damage must be reported to our Board President and/or National Director. If damage is not reported, contestant will be banned from the NDHSRA and/or NDJHRD permanently and reported to law authorities for prosecution.
- (5) Contestants will be disqualified for vandalism at any place or any time.
- (6) Cheating or attempting to cheat.
- (7) Any contestants or parents/guardians attempting to fix, threaten, bribe, influence or coerce any rodeo official at any time.
- (8) Missing any mandatory meeting, safety seminar, or equipment check.

Online Membership Application Process

From the NDJHRD.COM Membership Page, click on the link to the National Membership Portal.

<u>Returning Members</u>: you will enter your portal page by using the login box on the left side of the screen. Use your established username and password. If you have forgotten your information click on the link to request username and/or password.

<u>New Members</u>: You will need to log into the section on the right side of the screen by creating a username and password. Before you create a Username, please watch the *New User Signup Demo Video*. Write down your Username and Password as you will need them to sign into your personal page on the Portal for the remainder of your Junior High and High School years.

Online Instructions for Membership (returning and new members)

1-Complete all of your required information along with your parent's information. Once complete the online program will create a National Membership Application and a National Minor's Release Waiver of Liability which both need to be printed off, signed, notarized and uploaded back onto your portal page.

You will pay your national membership online (\$95.00 plus fees) as you complete the application process. This is mandatory in order to finish your paperwork. Your NDJHRD state fees will be paid by check at first rodeo of fall season.

2-Print off the North Dakota Junior High Rodeo Division paperwork that is found on the Membership page on the ndjhrd.com website. These forms need to be completed (the ND Waiver of Liability form also needs to be notarized) and uploaded to your portal page.

3-When uploading your documents, there is a documents section towards the bottom of your portal page where you upload your documents. There is a specific drop down box that you need to select when uploading your National Membership Application and one for your National Waiver. In regards to the State Forms, you can scan all state paperwork into one document and upload it to your page.

Your membership is not complete nor will you be able to enter any rodeos until your forms are uploaded and verified as complete. You will pay the \$40.00 state membership fee (payable to NDJHRD) at the first rodeo of the season. Be sure to bring a check/cash for your membership and a check/cash for your fees.

In order to enter the CDRC Jr High Rodeo, all forms must be uploaded to your portal by July 27th. Please begin this process ASAP so online entries may be posted!!!!
